1. FILING OF AN APPLICATION FOR THE REGISTRATION OF INDUSTRIAL DESIGN

1. basic fee – for one industrial design
2. additional charge for each subsequent design of multiple application

* *The applicant who is also the designer shall pay fees reduced by an amount of 50%.*

** *For the applications submitted by e-filing charges are reduced by an amount of 20%.*

2. MAINTENANCE OF AN INDUSTRIAL DESIGN FOR FIVE INITIAL YEARS AND PUBLICATION OF DATA ON INDUSTRIAL DESIGN

1. for one industrial design
2. additional charge for each subsequent design of multiple application

-	200 HRK

3. REQUEST FOR THE RENEWAL OF THE INDUSTRIAL DESIGN PROTECTION FOR THE PERIOD OF ADDITIONAL FIVE YEARS

1. for one industrial design
2. additional charge for each subsequent design of multiple application

*** 60 HRK	*** 400 HRK
*** 25 HRK	*** 200 HRK

*** *Where the fees and charges under this Tariff No are paid within the grace period of six months, the prescribed amounts shall be doubled.*

4. APPLICATION FOR PRIORITY CERTIFICATE

1. for one copy of Certificate
2. additional charge for each subsequent copy of the Certificate

5. APPLICATION FOR INDUSTRIAL DESIGN CERTIFICATE

1. basic fee
2. for each page of the Certificate over three pages

Note

Minimal total fees and charges of the procedure for the registration of industrial design and maintenance for the period of five years, which is without reduction and refers to one industrial design, shall include fees and charges under 1.1 and 2.1, or total amount of 650 HRK.

IMPORTANT NOTE:

This list specifies only basic fees and charges of the procedure for the registration and maintenance of the industrial design. Depending on the applicant's regular obligations settlement and on additional requests pending procedure, the applicant may incur additional charges not specified in this list. Certain categories of applicants are eligible for exemption from payment of fees and charges.
