2. MAINTENANCE OF A TRADEMARK AND PUBLICATION OF INFORMATION ON THE TRADEMARK

Charges for maintenance of a trademark **for the period of 10 years** and publication of information on the trademark in the official gazette:

a) Individual trademark

1. up to three classes of goods or services
2. additional charge for each class of goods or services exceeding three classes

b) Collective or guarantee trademark

1. up to three classes of goods or services

4. ISSUE OF A PRIORITY CERTIFICATE

2. additional charge for each additional copy of the Certificate

5. REQUEST FOR RENEWAL OF A TRADEMARK FOR THE PERIOD OF TEN SUBSEQUENT YEARS

a) Individual trademark

1. up to three classes of goods or services
2. additional charge for each class of goods or services exceeding three classes

*125 HRK	*1.500 HRK
-	*300 HRK

**Where the fees and charges are paid with delay (within the grace period of 6 months), the prescribed amounts shall be doubled*

b) Collective or guarantee trademark

1. up to three classes of goods or services
2. additional charge for each class of goods or services exceeding three classes

*250 HRK	*3.000 HRK
-	*600 HRK

**Where the fees and charges are paid with delay (within the grace period of 6 months), the prescribed amounts shall be doubled.*

NOTE:

Minimal total fees and charges of the procedure for the registration and maintenance of a trademark for the period of ten years, for individual trademark without reduction, shall include fees and charges under 1.a) 1. and 2.a)1., or the total amount of 2250 HRK. For collective or guarantee trademark the respective minimal charges are specified under 1.b)1. and 2.b)1., or the total amount of 4500 HRK.

IMPORTANT NOTE:

This list specifies only basic fees and charges of the procedure for the registration and maintenance of a mark. Dependent on the applicant's regular obligations settlement and on additional requests pending procedure, the applicant may incur additional charges not specified in this list. Certain categories of applicants are eligible for exemption from payment of certain fees and charges.
