Minimal total procedural costs for the registration of industrial design and maintenance for the period of five years, which is without reduction and refers to one industrial design, shall include costs under 1.1 and 2.1, or the total amount of 600 HRK / 79,63 EUR¹.

This list specifies only basic procedural costs for the registration and maintenance of the industrial design. Depending on the settlement of regular obligations by the applicant during the procedure and on other requests of the applicant, additional costs may incur that are not specified in this list. Certain categories of applicants are eligible for fee reduction.
