## Language

The working language of the WIPO Summer School will be English. Good knowledge of English is therefore expected from each participant.

## Registration fees

The enrolment fee to be paid to the State Intellectual property Office upon receipt of the notification of admission to school.

For students and young professionals from **developing countries and countries in transition and residing in those countries**, registration fee is:

Students: US\$ 100

Young professionals: US\$ 200

For students and young professionals from **developed countries** registration fee is:

Students: US\$ 250

Young professionals: US\$ 450

Payment: from April 20<sup>th</sup> to May 20<sup>th</sup> 2023.

## Climate

The climate in Dubrovnik is Mediterranean, the summers are dry and warm, and during June and July the temperature ranges between 25-30 degrees Celsius.

## Dress Code

We suggest „business casual“ dressing.

## Insurance and medical examination

Non-resident participants will be provided with insurance coverage for the duration of their stay in connection with the Summer School program.

Each participant will be required to present a medical certificate immediately upon registration on 26<sup>th</sup> June, 2023.

## **Currency**

The currency in Croatia is euro.

## **Travel, accommodation and living expenses**

Participants are responsible for their own travel to and from Dubrovnik, accommodation and living expenses during their participation in the WIPO Summer School Program.

The pre-booking of the rooms for the participants were made at the [Student dormitory of the University of Dubrovnik](#), and if they wish, they can confirm booking from 24<sup>th</sup> June and check out by 9<sup>th</sup> July 2023.

The prices for the stated period are as follows:

Single room – bed and breakfast: 80,00 €

Double room – bed and breakfast: 104,00 € (52 € per person)
